Sustainable Attire (SA)

SA is a public limited company which has been trading for 30 years in country P. It manufactures clothes which are made from sustainable cotton. SA has a brand image for protecting the environment and for producing high-quality products. SA's objectives are to increase profit, to increase market share and to survive.

SA has one factory in country P and uses batch production to manufacture its clothes. It employs 500 production workers. All of SA's raw materials, including cotton, come from sustainable sources. These raw materials are purchased regularly as SA uses just-in-time (JIT) inventory control. The Operations Director is considering whether quality control or quality assurance is the best method to use to achieve quality production.

SA's clothes are sold in country P through its own shops. Its products can also be purchased online from SA's website and delivered directly to customers. The Operations Director knows that the role of packaging is important.
