Option A: The nineteenth century

- 1 The revolutions of 1848 had different causes and outcomes.
 - (a) Describe the struggle against Austrian rule in Italy in 1848–49. [4]
 - (b) Why was there a revolution in Hungary in 1848? [6]
 - (c) ‘The revolution in France was the most successful of the revolutions of 1848.’ How far do you agree with this statement? Explain your answer. [10]

- 2 The struggle for Italian unification continued over several decades.
 - (a) What was agreed between Cavour and Napoleon III at Plombières in 1858? [4]
 - (b) Why did Cavour send Piedmontese forces into the Papal States in 1860? [6]
 - (c) ‘The 1848 revolutions in Italy played little part in the achievement of Italian unification.’ How far do you agree with this statement? Explain your answer. [10]

- 3 The USA had many problems before and after the Civil War.
 - (a) What was the Freedmen’s Bureau? [4]
 - (b) Why was the raid on Harpers Ferry important? [6]
 - (c) How far were Radical Republicans responsible for the failure of Reconstruction? Explain your answer. [10]

- 4 A number of factors increased tensions between European powers in the period before 1914.
 - (a) What was ‘Weltpolitik’? [4]
 - (b) Why was Germany concerned about the close relationship between Russia and France in the period 1894 to 1914? [6]
 - (c) How far were events in the Balkans responsible for the outbreak of the First World War in 1914? Explain your answer. [10]

Option B: The twentieth century

- 5** The Treaty of Versailles had some unexpected consequences.
- (a) Describe the role of Clemenceau in the peace negotiations. [4]
- (b) Why did the Treaty of Versailles have important consequences for the German people up to the end of 1923? [6]
- (c) How far was the Treaty of Versailles welcomed by the people of the victorious powers? Explain your answer. [10]
- 6** The Council of the League of Nations had to deal with international disputes and crises.
- (a) Describe how the Council of the League operated. [4]
- (b) Why was the League able to deal successfully with some international disputes in the 1920s? [6]
- (c) Which was the harder crisis for the League to deal with: Manchuria or Abyssinia? Explain your answer. [10]
- 7** After 1945, relations between the Soviet Union and the West gradually turned into a cold war.
- (a) What was the Warsaw Pact? [4]
- (b) Why did many European countries welcome the Marshall Plan? [6]
- (c) 'In the peace conferences of 1945 the main issue was what to do with Germany.' How far do you agree with this statement? Explain your answer. [10]
- 8** Between 1948 and 1981, dissatisfaction with Soviet control grew in Eastern Europe.
- (a) Describe the part played by Walesa in Poland in 1980–81. [4]
- (b) Why did the East German Government decide it was necessary to build the Berlin Wall? [6]
- (c) 'The reasons for opposition to Soviet control in Hungary in 1956 and Czechoslovakia in 1968 were the same.' How far do you agree with this statement? Explain your answer. [10]

Section B: Depth studies

Depth study A: The First World War, 1914–18

- 9** The First World War saw heavy fighting on both Eastern and Western Fronts.
- (a) Describe General Haig's leadership and tactics in the Battle of the Somme. [4]
 - (b) Why was Russian mobilisation in 1914 important? [6]
 - (c) Which was more important: the Battle of Verdun or the Battle of the Somme? Explain your answer. [10]
- 10** The First World War came to an end in November 1918.
- (a) What was the Armistice? [4]
 - (b) Why was the British naval blockade of Germany important? [6]
 - (c) Which was the more important in the last years of the war: the arrival of US troops in Europe or the failure of the Ludendorff Offensive? Explain your answer. [10]

Depth study B: Germany, 1918–45

- 11** The Weimar period had both achievements and challenges.
- (a) Describe the cultural achievements of the Weimar period. [4]
 - (b) Why was Stresemann's foreign policy important for Germany? [6]
 - (c) 'The main threat to the Weimar Republic between 1918 and 1933 was economic collapse.' How far do you agree with this statement? Explain your answer. [10]
- 12** Different groups had different experiences under Nazi rule.
- (a) What was the Final Solution? [4]
 - (b) Why was there opposition in Germany to Hitler during the Second World War? [6]
 - (c) 'Nazi policies towards women were welcomed.' How far do you agree with this statement? Explain your answer. [10]

Depth study C: Russia, 1905–41

- 13** The Tsar was constantly trying to deal with discontent.
- (a) Describe what happened in the March Revolution of 1917. [4]
 - (b) Why did Stolypin introduce agricultural reforms in the years 1906 to 1911? [6]
 - (c) 'The Tsar survived the 1905 Revolution by promising reforms.' How far do you agree with this statement? Explain your answer. [10]
- 14** After their seizure of power, the Bolsheviks faced many challenges.
- (a) Describe Trotsky's role in the Civil War. [4]
 - (b) Why was the New Economic Policy (NEP) important to Lenin? [6]
 - (c) 'Lenin was the main reason why the Bolsheviks were able to seize power in November 1917.' How far do you agree with this statement? Explain your answer. [10]

Depth study D: The United States, 1919–41

- 15** The experiences of different US industries in the 1920s varied enormously.
- (a) Describe the problems facing farming in the 1920s. [4]
 - (b) Why did traditional industries struggle in the 1920s? [6]
 - (c) 'The use of mass production by US industry was responsible for the boom of the 1920s.' How far do you agree with this statement? Explain your answer. [10]
- 16** The years 1929 to 1932 were momentous ones for the USA.
- (a) Describe Hoover's reactions to the Depression. [4]
 - (b) Why were many speculators ruined by the Wall Street Crash? [6]
 - (c) 'It was the Bonus Marchers who were responsible for Roosevelt's victory in the 1932 election.' How far do you agree with this statement? Explain your answer. [10]

Depth study E: The Second World War in Europe and the Asia–Pacific, 1939–c.1945

- 17** By 1941, Germany was fighting on several fronts.
- (a) Describe how Operation Sea Lion was meant to work. [4]
 - (b) Why was the Soviet Union able to defeat the German invasion? [6]
 - (c) ‘Dunkirk was a disaster for Britain.’ How far do you agree with this statement? Explain your answer. [10]
- 18** Resistance to the Axis powers was strong in different parts of the world.
- (a) Describe how the Germans reacted to the French Resistance. [4]
 - (b) Why did Allied bombing of German cities increase from 1943? [6]
 - (c) ‘The resistance movement in Malaya caused serious problems for the Japanese.’ How far do you agree with this statement? Explain your answer. [10]
