**EITHER**

- 1 XY Ltd (XYL) owns a factory. During a severe storm, the floor of the factory is flooded. XYL's safety policy is to close the factory until the floor has dried out. However, George, the factory manager, instructs staff to continue working while the floor is still wet. Jim, one of the workers, slips and breaks his leg. He is unable to work for several weeks.

Jim reads an article about a serious and incurable illness caused by long-term contact with a harmful chemical. He realises that he has been exposed to this chemical in XYL's factory and he becomes very anxious and depressed. He fears that he might develop the illness as he has worked at the factory for many years.

Advise the parties of their rights, responsibilities and potential remedies.

- 2 Liz and Kate are writing a book about local historical sites. Sean owns land on which there is an old castle. Liz and Kate obtain his permission to visit the castle and take photographs. To prepare for the visit, Liz flies a drone over Sean's land to film the castle. Sean does not give permission for the drone flight.

Kate and Liz visit the castle to take photographs. Kate tells Liz that she has heard stories of treasure buried in the grounds of the castle. Kate takes some tools from her bag and starts to dig. As she is digging, Sean arrives and tells them both to leave immediately. Liz leaves, but Kate refuses. Sean grabs Kate and pushes her off his land.

Advise the parties of their rights, responsibilities and potential remedies.
